READ COMPLETELY

It appears that we have a misunderstanding. Your skepticism is understandable, but has resulted from my failure to adequately brief you on this situation. The following cannot be shared:

"I" am not anonymous. "I" never have been anonymous. As far as you are concerned, my task was to investigate Project Serpo and determine whether classified information was being unlawfully leaked to the public and who the source of the information is, as a result of NUMEROUS FOIA requests. Such requests, can be problematic in certain situations.

To this end, I have found that the source is located in the Albuquerque, NM area and has sent you email messages using 4 separate identities. The physical computer hardware identified to have been the source of each message is the same. The IP header information that you provided to us was used to ensure that other source data information we obtained was, in fact, accurate. It was.

You and your friend's analysis is partially correct. Identifying individuals from email header information is not possible. With enough data, a physical computer can be identified. Separate confirmation is required to determine the authenticity of the data. That separate confirmation was obtained via human intelligence.

have the capacity to control the manner in which the IP header of an email message would be displayed. The manner used by "Anonymous" is inconsistent with an appropriate control scheme. The manner used identifies a specific computer in a specific location. A person who cannot be excluded from consideration as "Anonymous" exists in the Albuquerque location. That person is Richard Doty. It has also been confirmed by human intelligence that Mr. Doty contacted Kelly Neff and disclosed that he was attempting to convey information relating to project Serpo. It is confirmed that Mr. Doty contacted Bill Ryan for purposes of realying information.

It is also agreed that the IP headers could have been controlled to eliminate indication of a distinct IP address. This was not done by "Anonymous". Independent corroboration of the authenticity of the target in the suspect location confirms the analysis.

Based on these and other factors, such as an anticipated meeting between Mr. Doty and Mr. Ryan at the Laughlin UFO event, there is no remaining doubt that Mr. Doty is the conduit for information being released as "Project Serpo".

Further, to determine whether Mr. Doty was acting as a conduit for this information or was actually the source, note the email messages you received from Mr. Doty in testimonial to the authenticity of Project Serpo. - 2, The leak may or may not be acting as a conduit for an external source of information.
- 3, All supporting accounts and data has been provided by the leak. Some of that data has been provided under alternate cover.
- 4, The electronic data trail provided by the leak indicates that it may wish to be exposed, but cannot expose himself openly. If you believe your accepted conclusion that an official operation would control the IP header information, then determine why the operative responsible for the leak has left you a trail of breacrums. If the leak is official, then he has asked to be identified. If the operation is not official, then the leak has chosen to use your WebTV system to mask his electronic identity, rather than employ the means available to a covert operative of this nation's intelligence community. In your own words, Victor, think OUTSIDE the box.
