CASPER:

We have a potentially serious credibility problem that my colleague and co-moderator Bill Ryan has placed us in. Without authority and proper directive from you, he went ahead and streamed/posted what are alleged to be samples of the Eben language, and a photo of Ebe #1 in a stream sent late Thursday evening.

He knows that I have re-established contact with the "real" ANONYMOUS, so he should have checked with me FIRST before streaming what MIGHT be DISinformation. Of course, he does make the disclaimer that the photo of not SERPO related, but the Eben samples and tomorrow's diary entries area,... are they?

Coming tomorrow, are more Journal Entries from the Team Members. He misstated the facts when he said they were from "ANONYMOUS," suggesting that it was the same source whom I was dealing with; as you know, that's not true.

I have forwarded the most relevent "Reply Alls" and believe me, there was a flurry of them up until midnight! I still want to retain Bill to run the Web site and make public appearances,... but that's it. He doesn't have the discernment on what should/should not be streamed and be made public and going through proper channels.

QUESTION:

#1: Is the sample of the Eben language authentic, yes or no?

Washington, DC-based defense attorney Wayne Jaeschke, Jr, told me past midnight your time that that Eben language appeared years ago in a book entitled:

UFO CRASH AT AZTEC: A WELL-KEPT SECRET - by William Steinman w/ Wendelle Stevens, p.41!

#2: Is the photo of Ebe #1 authentic, yes or no?

#3: On your behalf, do you want me to make a public statement to my UFO Thread List -- which will be posted worldwide and on all online forums -- that some or all of what Bill is posting -- which was left for him at the recent UFO conference -- is DISinformation?

NOTE: NONE of this came from Rick Doty and, in fact, he and two of your DIA "look-outs" advised Bill against presenting it at the conference which Bill wisely did not do. However, now he's released it; what he should have done was run it by me FIRST, so I could pass it on to you for proper authentication and vetting, then I could have told Bill what to release and not release.

PLEASE ADVISE SOON ON MY MAKING A PUBLIC STATEMENT.
